YOUR PRIVACY IS IMPORTANT TO US

At Integrated Investment Group (IIG), we are committed to maintaining confidentiality of your personal information. Please read this to learn how we handle your personal information.

INFORMATION WE COLLECT

THE USA PATRIOT ACT AND YOUR INFORMATION

Under the USA PATRIOT Act, passed in response to the tragic events of September 11, 2001, to stop the unlawful laundering of money through U.S. financial institutions, all broker-dealers are required to verify the identity of their customers. As required by law, we use the information you provide to verify your identity.

Except as provided below, we do not disclose confidential information about customers or former customers to anyone, except as permitted by law.

We may also disclose your confidential personal information to non-affiliated third parties, as permitted by law.
